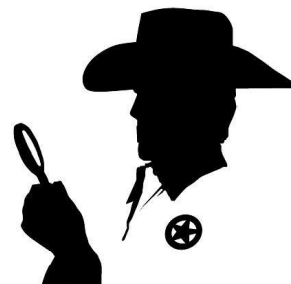

ABOUT THE INSTRUCTOR: JOE KENNEDY, SPECIAL AGENT, NCIS (RET.)

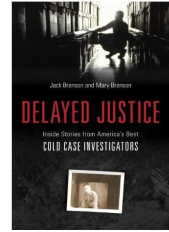
